REQUEST FOR PROPOSALS SCHOOL BOARD ATTORNEY/LEGAL SERVICES

Public Notice is hereby given that the Palisades Park Board of Education ("Board") is requesting proposals from interested and qualified firms to provide legal services in accordance with the "fair and open process" pursuant to N.J.S.A. 19:44A-20.5 et seq. & N.J.A.C. 6A-23A-5.2(a)(5) as further outlined in this Notice and the request for proposals provided by the Palisades Park Board of Education.

Proposals shall be submitted to the Business Administrator, Palisades Park Board of Education, 410 Second Street, Palisades Park, New Jersey 07650 on or before Thursday, January 2, 2020 at 4:00 p.m.

All firms submitting proposals must use and complete all forms and include all information required by the Request for Proposal. This shall include: 1. Presentation Packet; 2. Business Registration Certificate; 3. Political Contribution Disclosure Form; 4. Affirmative Action Affidavit; 5. Stockholder Disclosure Certification; and 6. Disclosure of Investment Activities in Iran.

Proposals must be placed in a sealed envelope/package and marked as "Proposal for School Board Attorney/Legal Services" on the front of the envelope/package. The Board does not accept electronic (e-mail) submission of proposals.

The Board reserves the right to reject any or all proposals and waive any informality in the process if it is in the best interest of the Board. No proposal may be deemed accepted until the adoption of a formal resolution by the Board.

Background

The Palisades Park Board of Education is a PreK-12 public school district providing educational services to approximately 1,800 students with a budget of \$28.8 million. The school district is comprised of one early childhood learning center, one elementary school, one junior/senior high school, together with separate buildings that house the Board of Education Office and the buildings and grounds annex. The district has multiple special education programs including many extra-curricular, interscholastic and intramural athletic programs.

Scope of Work

The Attorney shall be required to perform all legal services for the Board on an as-needed basis. Attorneys may submit proposals to provide services in General Counsel, Special Education, Labor/Personnel or for all service areas listed in the RFP.

A. General Counsel Services to be provided:

- Provide legal research and/or advisory opinions, as needed.
- Review and/or draft all contracts, Inter-Local and Inter-Agency agreements.
- Attend any and/or all meetings of the Palisades Park Board of Education as directed.
- Be readily available for meetings with the President, representatives of the Board of Education or district administrators upon request.
- Advise the Palisades Park Board of Education of changes in state and federal law and regulations, as well as court decisions, which will impact the district.
- Review and advise for legal notices, resolutions, Board policies and matters of district governance.
- Review and advise with matters including, but not limited to, procurement and service contracts, bid specifications, bidding matters, preparation and execution of contracts and contract disputes solution.
- Provide advice and counsel on all matters related to regular students, including discipline, attendance, adherence to rules and regulations, etc.
- Representation of the Board with respect to matters involving interface with the municipal governing body, including planning and adjustment boards, financial matters, jurisdictional matters, etc. and with state agencies such as the EDA, DOE, EPA, as needed.
- Provide assurance statements as required for financial audits, bonding matters and grant compliance.

B. Special Education Counsel Services to be provided:

- Review special education issues upon request and provide guidance to the Board and Administration.
- Represent the district in mediation, upon request.
- Representation of the district at all stages of mediation, including administrative law, commissioner, State Board and court proceedings until

- due process filed by parent/guardian. After which time, be available to consult with insurance appointed legal counsel.
- Serve as the district's liaison to the legal representatives/advocates of parents.
- Review special education contracts upon request.
- Any additional matters as directed by the Palisades Park Board of Education.

C. Labor/Personnel Counsel Services to be provided:

- Advise the Board in legal matters with respect to labor relations and personnel administration.
- Review grievances with the administration and assist in writing administrative responses to the same.
- Represent the Board in all arbitrations, administrative proceedings, court proceedings, etc. involving labor relations or personnel administration.
- Advise the Board on employment, employee discipline, seniority, tenure and other personnel administration matters.
- Advise on proposed contract language and bargaining proposals.
- Develop possible salary guides in accordance with Board guidelines.
- Prepare final contract documents upon settlement and ratification of tentative agreements.

Services to be included in **each** of the service areas:

- Legal counsel and advice to the Board and Administration.
- Timely advice and counsel on emergent matters. Counsel response is expected, at least verbally to be followed in writing, within a maximum of 24 hours upon inquiry made by the Board or Administration.
- Written legal opinions upon request.
- Initiate and/or defend lawsuits as necessary at the direction of the Board.
- Prepare all necessary legal documents.
- Attend any and/or all meetings for the Board, meetings with committees or third parties, upon request.
- Work cooperatively with legal counsel of insurance companies, consortiums or other collective with whom the Board may be affiliated.
- Represent the school district in all judicial and/or administrative proceedings within the specific service area in which the district or any of its Board members, administrators or agents may be a party or have an interest.
- Provide written, timely notification to the Board of changes in school law or state regulations, including court and administrative decisions that may impact the operation of the school district.
- Conduct in-service programs on specified legal issues for appropriate staff members, upon request.
- Fulfill other legal duties as are commonly accepted and assigned.

Qualifications

The principals and associates of the firm who provide legal services must be properly licensed by the State of New Jersey to practice law in the State. The Attorney shall furnish the Board with a curriculum vitae/firm resume that evidences a minimum of ten (5) years of experience in the representation of public entities, including boards of education, municipalities, and County or State government agencies. The Board is seeking a candidate that has significant experience and familiarity with State and Local Government practices and rendering legal services to public entities. An interview of qualified candidates will be scheduled by the Board.

SUBMISSION REQUIREMENTS

All submissions shall include the following minimum information:

- 1. Number of individual(s) to be assigned to perform tasks.
- Professional experience and education of individual(s) to be assigned including a listing of experience with other New Jersey boards of education. The District is requesting a minimum of (5) years of professional experience with New Jersey Boards of Education.
- 3. A Statement concerning the ability of the firm/individual to perform tasks assigned by the Board in a timely fashion.
- 4. Professional licenses and certifications held by the individual(s) to be assigned.
- 5. A description of the support staff available to the individual(s) to be assigned.
- 6. A copy of a Certificate of Insurance, issued by an insurance carrier licensed in the State of New Jersey, for the firm showing the amount of professional liability and workers compensation insurance and all other insurance coverages in place as of the date of the submission of the response to this RFP.
- 7. A list of three (3) current and two (2) former professional references with addresses and telephone contact numbers. Three (3) must have direct knowledge relating to your experience in the requested service.

Contract Period:

The initial term of the contract for this proposal shall be for the 2020 calendar year.

<u>Proposal</u>

The Attorney shall submit all information required by the Request for Proposals, including the hourly rate for which the Attorney agrees to provide services. If the Attorney is requesting a retainer, a detail of what the retainer will cover must be included.

The Attorney must submit an original proposal and three (3) copies that include the following:

All proposals are due on Thursday, January 2, 2020 at 4:00 p.m. Submittals received after the date specified will be returned unopened. All proposals shall remain firm for a period of sixty (60) days after the date specified for receipt of proposals.

B. Description of Services

Provide a description of all services to be rendered with a detailed explanation of how the services will be provided. By submitting a proposal, the Attorney acknowledges that he/she fully understands the scope of work, activity and service.

C. Qualifications; Relevant Experience

Evidence and documentation shall be submitted highlighting qualifications and experience that will assist the Board in the evaluation and selection process.

D. Fee Proposal

Provide hourly rate for partners, associates and paralegals.

E. Miscellaneous Provisions

All Attorneys are required to provide sufficient information in their proposals for evaluation.

F. The Attorney acknowledges that he/she has read this Request for Proposal, has

a full understanding and agrees to be bound by the terms and conditions. Proposals must be submitted prior to the time and date specified by mail or hand delivered to the Board of Education. **No facsimile or e-mail proposals will be accepted**.

- G. The Palisades Park Board of Education reserves the right to reject any or all proposals in whole.
- H. The Palisades Park Board of Education reserves the right to contact references provided with the proposal.
- I. Any departures from this Request for Proposals must be noted. Any conditions or terms must be written and included with the RFP.
- J. Proposed Attorneys shall be licensed or authorized to practice law in the State of New Jersey.
- K. Include any additional information, which you believe will be useful to the Palisades Park Board of Education in its selection process.

<u>References</u>

Provide a list of the boards of education for which you have provided legal services within the last three (3) years. Include the name of the entity, the name and telephone number of a contact person, and the name of the partner that is assigned to that district.

Award of Contract

The procedures developed for the award of the contract constitutes a "fair and open" process pursuant to N.J.S.A. 19:44A-20.7 and N.J.A.C. 6A:23A-5.2 (a)(5). This Request For Proposals is for Professional services which are exempt from bidding and the obligation to award such contracts based on the requirements of N.J.S.A. 18A: 18A-1 et seq., based on the lowest price, and the contract will not be awarded based on that sole criterion, but based on the proposal that, in the determination of the Board, price and other factors considered, is in the best interests of the Board. The Board reserves the right to reject any and all proposals, and to waive any informality in the process if the board deems it to be in its best interest. No proposal may be deemed accepted until the adoption of a formal resolution by the Board.

A decision on whether the contract will be awarded and to whom it will be awarded shall be made within sixty (60) days from the date the proposals are opened. The contract, if awarded, shall be awarded to the Attorney who submits the most advantageous proposal based on price and the qualifications of the Attorney and other factors considered. The evaluation will consider:

- A. a. Experience and reputation in the field;
- B. b. Knowledge of the subject matter to be addressed under the contract;
- C. c. Availability to accommodate any required meetings of the Board;
- D. d. Compensation proposal;
- E. e. Other factors, if demonstrated, to be in the best interest of the Board.

The Board anticipates establishing in its future budget a legal service contract amount not to exceed based on its past experience and the TGES for legal services as compiled by the NJDOE. The TGES for this size District is \$64,800.00

Technical Criteria and Qualifications

The following criteria will be considered by the Board in evaluating the proposals submitted in response to this Request for Proposals:

- I. Proposed methodology:
 - A. Does the attorney's proposal demonstrate a clear understanding of the scope of services and related objectives?
 - B. Is the attorney's proposal complete and responsive to the specific RFP requirements?
 - C. Has the past performance of the attorney's proposed methodology been documented?
 - D. Does the attorney's proposal reflect that the attorney is knowledgeable in the areas of law affecting the District, including but not limited to, procurement practices, employment matters and general litigation procedures?
- II. Management criteria:
 - A. Management:
 - 1. Will the attorney provide all services in a timely fashion to meet the Board's needs?
 - 2. How is work distributed among the attorney's staff, if there are partners and associates?
 - B. History and experience in performing the work:
 - 1. Does the attorney document a record of reliability of timely response?
 - 2. Does the attorney demonstrate a track record of reliable and competent service?
 - 3. Does the attorney document relevant experience?
 - 4. Does the attorney have a record of moral integrity?
 - C. Availability of personnel, facilities, equipment and other resources:
 - 1. To what extent does the attorney rely on in-house resources as opposed to contracted resources?
 - 2. Are the availability of in-house and contract resources documented?
 - D. Qualification and experience of personnel:

- 1. Documentation of experience in performing similar work by employees and, when appropriate, sub-consultants.
- 2. Documentation of oversight and mentoring of newer/inexperienced employees.

III. Cost criteria:

- A. Cost of goods to be provided or services to be performed:

- B. Attorney's financial stability and strength:

Laws

The Attorney shall comply with all applicable laws, statutes, regulations, and ordinances and any order issued by any governmental entity. The laws of the State of New Jersey shall govern this contract. The contract will require that all attorney billing shall comply with the provisions of N.J.A.C. 6A:3A-5.2 (a) 4 , and for any contract where the proposed amount not to exceed constitutes in excess of 130% of the TGES, provisions to reduce costs shall be implemented pursuant to N.J.A.C. 6A:23A-5.2(a) (3).

Law Against Discrimination

During performance of this contract, the Professional and his sub-consultants agree to comply with <u>P.L.</u> 1975, <u>c</u>.127, "Law Against Discrimination" in accordance with provisions described in Exhibit "A" attached hereto. The mandatory language of <u>N.J.A.C.</u> 17:27-1.1 <u>et seq.</u> promulgated by the Treasurer pursuant to <u>N.J.S.A.</u> 10:5-31 <u>et seq.</u>, as amended and supplemented from time to time is attached hereto made a part hereof and incorporated herein by reference. The contract with the Professional may be rescinded if the Professional fails to submit proof of compliance with the regulations set forth in <u>N.J.A.C.</u> 17:27. Indemnification

The Professional shall indemnify and hold the Board harmless for any and all claims, injuries and damages, including the reimbursement of reasonable attorneys' fees and cost of litigation that may occur as a result of the provision of legal services to the Board.

<u>Insurance</u>

The Professional agrees to obtain and maintain for the entire term of this Agreement the following insurance coverage:

Workers' Compensation – In compliance with the Workers' Compensation Law of the State of New Jersey.

Professional Liability – claims made basis in the annual aggregate

\$1,000,000.00

Any other insurance as deemed necessary by the Board of Education.

Failure by the Professional to supply such shall result in default.

The insurance companies for the above coverage must be licensed by the State of New Jersey and acceptable to the Board. The Professional shall not take any action to cancel any of the insurance required under the agreement without the approval of the Board. The maintenance of insurance under this section shall not relieve the Professional of any liability greater than the insurance coverage.

All policies must incorporate a provision requiring the giving of notice to the Board by certified mail, return receipt requested, at least thirty (30) days prior to the cancellation or non-renewal of any insurance policy required herein.

Business Registration Certificate

A contractor, subcontractor or supplier that fails to provide a copy of a business registration as required pursuant to N.J.S.A. 52:32-44 et seq., or that provides false business registration information under the requirements of either of those sections, shall be liable for a penalty of \$25.00 for each day of violation, not to exceed \$50,000 for each business registration copy not properly provided under a contract with a contracting agency. The contractor shall indemnify and hold harmless the Board from and against any and all fines, taxes, penalties, interest, claims, losses, costs and expenses of any kind arising out of or resulting from or in connection with the contractor's failure to comply with N.J.S.A. 52:32-44 as amended from time to time.

Annual Political Contributions Disclosure

Pursuant to N.J.S.A. 19:44A-20.27 (P.L. 2005, c.271, s.3), the Attorney may be required to file an annual disclosure statement with the New Jersey Election Law Enforcement Commission. Pursuant to N.J.A.C. 6A:23A-6-3 (a1-4) please note the following:

A. Pursuant to N.J.A.C. 6A:23A-6.3 (a2) Reportable Contributions:

No board of education will vote upon or award any contract in the amount of \$17,500 or greater to any business entity which has made a contribution reportable by the recipient under <u>P.L.</u>1973, <u>c.83</u> (codified at N.J.S.A. 19:44A-1 et. seq.) to a member of the board of education during the preceding one year period.

B. Pursuant to N.J.A.C 6A:23A-6.3 (a2,3) Contributions During Term of Contract:

Contributions reportable by the recipient under <u>P.L.</u> 1973, <u>c.83</u> (codified at <u>N.J.S.A.</u> 19:44A-1 et. seq.) to any member of the school board from any business entity doing business with the school district are prohibited during the term of the contract.

When a business entity referred in 4.1(e) is a natural person, contribution by that person's spouse or child that resides therewith, shall be deemed to be a contribution by the business entity. When a business entity is other than a natural person, a contribution by any person or other business entity having an interest therein shall be deemed to be a contribution by the business entity.

C. Pursuant to <u>N.J.A.C</u>. 6A:23A-6.3 (a4) Political Contribution Disclosure Form:

All bidders shall submit with their bid package a completed and signed Chapter 271 Political Contribution Disclosure Form. The Chapter 271 form will be reviewed by the district to determine whether the vendor is in compliance with the aforementioned N.J.A.C. 6A:23A-6.3 (a2) Award of Contract.

Termination

Either party may terminate the consultant agreement upon providing thirty (30) days written notice to the other party. Written notice shall be sent certified mail, return receipt requested.

C. 271 POLITICAL CONTRIBUTION DISCLOSURE FORM

Public Agency Instructions

This page provides guidance to public agencies entering into contracts with business entities that are required to file Political Contribution Disclosure forms with the agency. **It is not intended to be provided to contractors.** What follows are instructions on the use of form local units can provide to contractors that are required to disclose political contributions pursuant to N.J.S.A. 19:44A-20.26 (P.L. 2005, c. 271, s.2). Additional information on the process is available in Local Finance Notice 2006-1 (http://www.nj.gov/dca/divisions/dlgs/resources/lfns_2006.html). Please refer back to these instructions for the appropriate links, as the Local Finance Notices include links that are no longer operational.

- 1. The disclosure is required for all contracts in excess of \$17,500 that are **not awarded** pursuant to a "fair and open" process (N.J.S.A. 19:44A-20.7).
- 2. Due to the potential length of some contractor submissions, the public agency should consider allowing data to be submitted in electronic form (i.e., spreadsheet, pdf file, etc.). Submissions must be kept with the contract documents or in an appropriate computer file and be available for public access. **The form is worded to accept this alternate submission.** The text should be amended if electronic submission will not be allowed.
- 3. The submission must be **received from the contractor and** on file at least 10 days prior to award of the contract. Resolutions of award should reflect that the disclosure has been received and is on file.
- 4. The contractor must disclose contributions made to candidate and party committees covering a wide range of public agencies, including all public agencies that have elected officials in the county of the public agency, state legislative positions, and various state entities. The Division of Local Government Services recommends that contractors be provided a list of the affected agencies. This will assist contractors in determining the campaign and political committees of the officials and candidates affected by the disclosure.
 - a. The Division has prepared model disclosure forms for each county. They can be downloaded from the "County PCD Forms" link on the Pay-to-Play web site at http://www.nj.gov/dca/divisions/dlgs/programs/lpcl.html#12. They will be updated from time-to-time as necessary.
 - b. A public agency using these forms should edit them to properly reflect the correct legislative district(s). As the forms are county-based, they list all legislative districts in each county. Districts that do not represent the public agency should be removed from the lists.
 - c. Some contractors may find it easier to provide a single list that covers all contributions, regardless of the county. These submissions are appropriate and should be accepted.
 - d. The form may be used "as-is", subject to edits as described herein.
 - e. The "Contractor Instructions" sheet is intended to be provided with the form. It is recommended that the Instructions and the form be printed on the same piece of paper. The form notes that the Instructions are printed on the back of the form; where that is not the case, the text should be edited accordingly.
 - f. The form is a Word document and can be edited to meet local needs, and posted for download on web sites, used as an e-mail attachment, or provided as a printed document.

5. It is recommended that the contractor also complete a "Stockholder Disclosure Certification." This will assist the local unit in its obligation to ensure that contractor did not make any prohibited contributions to the committees listed on the Business Entity Disclosure Certification in the 12 months prior to the contract. (See Local Finance Notice 2006-7 for additional information on this obligation at http://www.nj.gov/dca/divisions/dlgs/resources/lfns_2006.html) A sample Certification form is part of this package and the instruction to complete it is included in the Contractor Instructions. NOTE: This section is not applicable to Boards of Education.

C. 271 POLITICAL CONTRIBUTION DISCLOSURE FORM

Contractor Instructions

Business entities (contractors) receiving contracts from a public agency that are NOT awarded pursuant to a "fair and open" process (defined at <u>N.J.S.A.</u> 19:44A-20.7) are subject to the provisions of P.L. 2005, c. 271, s.2 (<u>N.J.S.A.</u> 19:44A-20.26). This law provides that 10 days prior to the award of such a contract, the contractor shall disclose contributions to:

- any State, county, or municipal committee of a political party
- any legislative leadership committee*
- any continuing political committee (a.k.a., political action committee)
- any candidate committee of a candidate for, or holder of, an elective office:
 - o of the public entity awarding the contract
 - o of that county in which that public entity is located
 - o of another public entity within that county
 - o or of a legislative district in which that public entity is located or, when the public entity is a county, of any legislative district which includes all or part of the county

The disclosure must list reportable contributions to any of the committees that exceed \$300 per election cycle that were made during the 12 months prior to award of the contract. See <u>N.J.S.A.</u> 19:44A-8 and 19:44A-16 for more details on reportable contributions.

N.J.S.A. 19:44A-20.26 itemizes the parties from whom contributions must be disclosed when a business entity is not a natural person. This includes the following:

- individuals with an "interest" ownership or control of more than 10% of the profits or assets of a business entity or 10% of the stock in the case of a business entity that is a corporation for profit
- all principals, partners, officers, or directors of the business entity or their spouses
- any subsidiaries directly or indirectly controlled by the business entity
- IRS Code Section 527 New Jersey based organizations, directly or indirectly controlled by the business entity and filing as continuing political committees, (PACs).

When the business entity is a natural person, "a contribution by that person's spouse or child, residing therewith, shall be deemed to be a contribution by the business entity." [N.J.S.A. 19:44A-20.26(b)] The contributor must be listed on the disclosure.

Any business entity that fails to comply with the disclosure provisions shall be subject to a fine imposed by ELEC in an amount to be determined by the Commission which may be based upon the amount that the business entity failed to report.

The enclosed list of agencies is provided to assist the contractor in identifying those public agencies whose elected official and/or candidate campaign committees are affected by the disclosure requirement. It is the contractor's responsibility to identify the specific committees to which contributions may have been made and need to be disclosed. The disclosed information may exceed the minimum requirement.

The enclosed form, a content-consistent facsimile, or an electronic data file containing the required details (along with a signed cover sheet) may be used as the contractor's submission and is disclosable to the public under the Open Public Records Act.

The contractor must also complete the attached Stockholder Disclosure Certification. This will assist the agency in meeting its obligations under the law. **NOTE: This section does not apply**

to Board of Education contracts.

N.J.S.A. 19:44A-3(s): "The term "legislative leadership committee" means a committee established, authorized to be established, or designated by the President of the Senate, the Minority Leader of the Senate, the Speaker of the General Assembly or the Minority Leader of the General Assembly pursuant to section 16 of P.L.1993, c.65 (C.19:44A-10.1) for the purpose of receiving contributions and making expenditures."
